



Certificate IV in Electrical - Instrumentation - UEE40420 Course Description:

This course provides you with the skills and knowledge to select, install, commission, fault find and maintain equipment and systems for the control of plant, machines and processes.

Duration and Mode of Delivery:

Stage 1: Theory

Theory completed online self-paced. Hours vary pending required units per students (approx. 70hrs pending electives selected).

Stage 2: Practical – Up to 2 weeks

Practical completed in our Brisbane, Sydney or Melbourne training centre. Intensive practical assessment requiring students to utilise our live functioning equipment to meet the requirements of the training package and gain valuable hands on experience.

Course Entry Requirements and Accreditation:

*Students must hold current 'Unrestricted Electricians Licence' or its equivalent issued in an Australian state or territory and /OR UEE30820 Certificate III in Electrotechnology Electrician prior to enrolling.

This is a Nationally Recognised course with successful students receiving a UEE40420 - Certificate IV in Electrical - Instrumentation Qualification.

Possible job titles and roles relevant to this qualification include Instrument Fitter, Instrument Technician, Plant Instrument Technician, E&I Technician, I&E Technician, Instrument Technician, Plant Operator, Process Technician & Maintenance Technician.

What is the Higher Level Skills program?

The Higher Level Skills program aims to assist individuals to gain the higher-level skills required to secure employment or career advancement in a priority industry, or to transition to university to further their studies.

If you are a Queensland resident and have completed your UEE30820 Certificate III in Electrotechnology Electrician (or an equivalent) Qualification and/or hold an Unrestricted Electrical Licence, you may be eligible to receive Government Funding Assistance to complete this course. Eligible students under the Skills Assure Higher Level Skills Program will need to pay a student contribution fee as shown in the cost tab.

Are you eligible to participate? You must:

- be a Queensland resident
- be aged 15 years or over, and no longer at school
- be an Australian or New Zealand citizen or Australian permanent resident (including humanitarian entrants), or a temporary resident with the necessary visa and work permits on the pathway to permanent residency;
- not hold a Certificate IV qualification funded through the Higher Level Skills Program before.

Eligibility for Concessional Students is/has:

- a holder of a Health Care or Pensioner Concession Card or is the partner or a dependant of a person who holds a Health Care or Pensioner Concession Card and is named on the card.
- able to provide us with an official form under Commonwealth law confirming that the student, their partner, or the person of whom the student is a dependant, is entitled to concessions under a Health Care or Pensioner Concession Card
- Aboriginal or Torres Strait Islander
- a disability
- an adult prisoner
